SANJAY BHATT of West Palm Beach, FL, s/o Ashwin & Kasturi Bhatt of Houston, TX was the lead reporter on a team that covered last fall's anthrax attack in Florida, and in April he accepted the Green Eyeshade Award, an 11-state journalism competition, on behalf of The Palm Beach Post. This summer he morphs into a disease detective at the U.S. Centers for Disease Control and Prevention in Atlanta under the competitive Knight fellowship open to journalists worldwide. Earlier this year, he was named to the board of directors of the national Association of Health Care Journalists.

Dr. GOPAL A. BHANDARKAR of Bayport, NY was elected as the Trustee of the Brookhaven Memorial Hospital.

GEBEL, is a joint venture between the US Multinational, General Electric and the Indian Electronics giant, Bharat Electronics. Call us whenever you need our help." Of course, I thanked them for their kind gesture.

On the way I encountered the same security lady, who had volunteered to help me. Looking at me, with wonder in her eyes, she said, "Mam! I could never believe that you could walk so fast and well!"

I too wondered why she spoke like that. Then only I realized that, all the while I was waiting, I was sitting in a wheel chair!

Dear Editor: I belong to a local pooja group and we meet on a monthly basis. Our 1-1/2 hour session includes bhajans, chants, meditation and spiritual discussions. One of the members answers some of the common questions pertaining to the spiritual practices followed since ages and I'll present them to Khabbar readers. I prefer to remain anonymous. Thanks

Why do we have a prayer room?

Most Hindu homes have a prayer room or altar. A lamp is lit and the Lord worshipped each day. Other spiritual practices like "japa" (repetition of the Lord's name), meditation, "paaraayana" (reading of the scriptures), prayers, devotional singing etc. is also done here. Special worship is done on auspicious occasions like birthdays, anniversaries, festivals and the like. Each member of the family - young or old - communes with and worships the Divine here.

The Lord is the owner of the entire creation. He is therefore the true owner of the house we live in too. The prayer room is the master room of the house. This notion rids us of false pride and possessiveness.

The ideal attitude to take is to regard the Lord as the true owner of our homes and ourselves as the caretakers of His home. But if this is rather difficult, we could at least think of Him as a very welcome guest. Just as we would house an important guest in the best comfort, so, too we felicitate the Lord's presence in our homes by having a prayer room or altar, which is, at all times, kept clean and well decorated.

Also the Lord is all pervading. To remind us that He resides in our home with us, we have prayer rooms. Without the grace of the Lord, no task can be successfully or easily accomplished. We invoke His grace by communing with Him in the prayer room each day and on special occasions.

Each room in a house is dedicated to a specific function like bedroom for resting and sleeping, the drawing room to receive

guests, the kitchen for cooking etc. the furniture, decor and the atmosphere of each room are made conducive to the purpose it serves. So too for the purpose of meditation, worship and prayer, we should have a conducive atmosphere - hence the need for a prayer room.

Sacred thoughts and sound vibrations pervade the place and influence the minds of those who spend time there. Spiritual thoughts and vibrations accumulated through regular meditation, worship and chanting done there pervade the prayer room. Even when we are tired or agitated, by just sitting in the prayer room for a while, we feel calm, rejuvenated and spiritually uplifted.

A brief history of Kolakere Prabhus

Kadambi Prabhus , Kolakere Prabhus & Bolanthur Prabhus are all belonging to the KOLAKERE House. The evolution of Kolakere family, which spreaded it's wings is an interesting story. Among Gowda Saraswath Brahmins there is no parallel history to Kolakere Prabhus.

My grandfather Late Kolakere Venkatraya Prabhu, and my Late father Kadambi Manjunath Prabhu have given me the knowledge about our family almost since my 10th year. I have made an earnest effort to investigate the happenings through records and consulting senior persons like my uncles namely Kolakere Govinda Prabhu, Kolakere Dasanna Prabhu and Kolakere Ram Narayana Prabhu.

After the fall of Kolakere Prabhu family, the Kadambi Prabhus migrated back to Kolakere House and managed the affairs. Although Kadambi Prabhus are the offshoot of Kolakere Prabhus the present Kolakere Prabhus are all Kadambi Prabhus who came back to Kolakere House. Thus Kolakere and Kadambi are the titles, which are synonymous to one and other. Both are respected in Mogaranadu 1000 seemas and Vittal 2000 seemas.

Kolakere & Kadambi Prabhus

The inquisition of Goa speaks of dispersal of Christians and Brahmins from the state of Goa to the neighboring places on the entire West Coast from Bombay to Cochin. The migrants left Goa along with their Kuladevatha statues, gold and members of their families. KOLAKERE PRABHUs belong to KASHYAP gothra and SRI DEVAKI KRISHNA MAHALAXMI RAVALNATH is their Kuladevatha. About 600 years ago the families of Prabhus came and settled at Bantwal adjacent to the river Nethravathi. Bantwal was a commercial capital of Nandar Dynasty. It is believed that our elders brought gold coins, which could not be estimated.

The Prabhus family started their commercial trading business in Bantwal. On seeing the wholesale business, export-import business and a great charity (Dana Dharma), the Kings of Nandar Dynasty appointed Anantha Prabhu as his Commercial Minister.

Kolakere House

Ruled by Jain family known as BALLALS. They were holding large acres of land and considered to be the 4th Samants(LAND LORDS)in Mogarnadu Dynasty covering 1000 seemas. The Ballals were 7 brothers and were notorious in their deeds. Sri Ullalthi, Goddess spirit was born in Kolakere House and Kolakere is considered to be a dominant house in the Mogarnadu Dynasty and enjoyed high status.

These Ballals are related to the Balthila Beedu, the 3rd dominant House of Samants in Mogarnadu 1000 seemas. The 2 brother Daivas were occupants in Balthila Beedu where Sri Ullalthi also joined them.

These Ballals were dealing with our Prabhu family for all their requirements in Business term. It so happened that all the 7 brothers of Ballals vanished due to their internal feud. And only women had survived. She approached the King of Nandar and requested with His Majesty to make necessary arrangements to pay off large debts due to Prabhus. The King calls the Prabhu and tells him to takeover the Kolakere House and the property towards the debts. Accordingly, the Kolakere House along with vast landed property came into the control of Prabhus.

The Kings of Nandar Dynasty was pleased with the wisdom of Prabhus and requested him to come over to Nandar and to stay with the Majesty. Thus, when the Kolakere House came under Prabhus, all were in Nandar. The Business place was Bantwal, a commercial center of dominance.

The problems for Prabhu to stay in a Jain House was because of cultural difference. Jain Houses of Samants are called as Beedu. There was Spirit worship in the house, which Prabhus found difficult to adjust. Prabhus are Madhwa/Vaishnav Brahmins known as Gowda Saraswat Brahmins. The local Tulu Culture was strange and they were not ready to accept this change. Hence, Prabhu thought of staying in Nandar but would like to hold the Kolakere House and landed properties. It was a great prestige to be known as LAND LORDS/SAMANTS. Samants are little Kings under the main King. They are nowadays considered as Governors.

That position of Samants had high paraphernalia and were honored by the people. It was a high status position in the Government of the King. For all major issues, the Samants were to be consulted and opinions were to be collected by the King, especially in revenue,

security, and development matters. A Samant represents the King. The Samants Rajas were carrying the Honorable Sword, traveling in a palanquin under the Royal Umbrella White in color. The Nandar Kings and 4 Samants from (1) Odal Guthu (2) Punjalimar Guthu (3) Balthila Beedu and (4) Kolakere Beedu.

Prabhus were the first non-Jains to become the Samant in Nandar Dynasty. In Tulunadu Dynasties, Prabhus were the first to become Ministers and belonging to the House of Lords i.e. Lords of Kolakere House.

In order to have better control on Kolakere Beedu, for a temporary period, Prabhus were staying in Kalladka (town closer to Kolakere House).

In the earlier paragraph it was discussed that as Gowda Saraswath Brahmins we had great difficulty in accepting Bhootharadhana (spirit worship) where offerings of cocks (bird) and Pig etc., form the Tulunadu custom of praying for spirits. Gowda Saraswaths are Aryan Brahmins. In Tulunadu a Dravidian state, there were differences in living, food marriage customs, God worship etc. The local people were pressurizing Prabhus to accept the local customs in the interest of the citizens.

Accordingly, during the time of Navarathri/Dasara, Prabhus are to worship for Nava Durga and to read Sri Devi Parayana. It was on the 5th day (Panchami) in the night in the dreams of Prabhu Devi appeared. Devi told Prabhu that during the day he had read from Devi Parayana the chapter on Devi killing the demon Dhumaraksasha. In Tulunadu the same Devi is called as Dhoomavathi. As Brahmins worship in their own way which is accepted by Goddess same as local people worship in their own way which is also accepted by her. Hence, Prabhus should also practice and participate in all rituals and customs of local system. Daiva Dhoomavathi promised Prabhu to save him and his family from all evils and difficulties. On the same day while milking the cow the blood was found in the milk. The local servants informed Prabhu that by worshiping Dhoomavathi, such happenings get stopped. That was also the firm belief of Jains in Kolakere House. Jains who are not Hindus also worship spirits in order to go at par with local beliefs and worships.

We constructed a new house in Kolakere and named it as "Kolakere Guthu" and changed the name from "Beedu" to "Guthu". Kolakere Guthu is in the Hindu architect having the God worship of Lord Narasimha. On the front room you find the cradle for Daiva Dhoomavathi. Dhoomavathi is the spirit in the house. The Sanskrit name for Dhoomavathi is "Dhoomrakshi". Dhoomavathi is always associated with her right hand assistant known as BUNTA, a male daiva. Dhoomavathi is the female daiva of higher status forms the part of NavaDurga. The Kolakere House daiva Dhoomavathi is the right assistant to the superior Daiva Ullalthi. Hence, a number of daivas are inter connected to Kolakere House. The Prabhu family started worship of Daivas/spirits as a result started occupying a leading and dominating position in the Tulunadu.

The powerful personality who was a minister in the court of Nandar Dynasty was one Sri Anantha Prabhu. He is considered to be the founder or Moola Purusha for Kolakere Prabhus. The person who constructed and stayed in Kolakere House is Sri Govinda Prabhu. In the family tree of Prabhus, Sri Govinda Prabhu's name one can see at the top.

Kolakere and Balthia Beedu

Once upon a time, both the houses were ruled by BALLALS who were Jains. They were cousins and lived in harmony with vast lands and properties in larger part of Mogarnadu 1000 seemas.

Balthila Beedu is the royal palace or place for the Mogarnadu 1000 seemas royal spirits known as Ajwara Daivangalu (Brother Daivas-Elder and Younger). Thus Balthila Beedu became a royal court in Mogarnadu seema. All the disputes arising in the area were settled in the court (Chavadi) of Balthila Beedu.

Annappa Panjurli a powerful spirit of Kshetra Dharmastala having seen the Dharma conducted in Balthila Beedu and the part of Shiva Shakti-the two brothers, came and occupied in Balthila Beedu. Subsequently, the brothers (Daivas) came over to Kolakere when the Goddess Shakti Ullalthi was occupying in Kolakere. These two brothers, Ullalthi and House spirit Dhoomavathi all go to Mular where the Ullalthi Bhandaramane is situated. Ullalthi being No.1 royal Daiva in Mogarnadu seema, Kolakere being the birth House of Ullalthi, thus Kolakere occupied No.1 place of importance in the entire Mogarnadu seema. Kolakere is considered as the Holiest place in Mogarnadu seema because of birth place (Moola stana\ Janma stana) of Ullalthi.

Balthila Beedu and Kolakere House belonging to the same family of Ballals. The elder brother's House was Balthila Beedu and younger brother's House was Kolakere House. The popular person in Balthila was Jathanna Ballal and the one from Kolakere was Mahishekara Ballal. They used to move around on Horses. Among Daivangalu, the elder brother's House was Balthila and younger brother's House was Kolakere. Again this made Kolakere House to occupy a prominent place.

The Ullalthi and her two brothers (Younger & Elder) annual festivals are conducted twice a year. These festivals are conducted by both Balthila and Kolakere house people. In absence of any one, the festivals are not conducted. Kolakere House Prabhus have donated lands for the purpose of Nitya Viniyoga (Daily Pooja) and for miscellaneous programmes in favor of Ullalthi.

Above all, Kolakere House became powerful after the family of Ballals was ruined by the House Daivas Dhoomavathi and Bunta due to indecent behavior of Ballals Prabhu family occupied the House. Prabhus were very rich in those days and were in commercial\business activities. They used to supply commodities and money to the big land- Lords, agriculturist etc. Hence the

position of Prabhus in Kolakere House became more dominant in that entire area. At one time, Kolakere Prabhus had lent money and commodities to the Rajas of Vittal Dynasty consisting of 2000 seemas. (To Be Continued)

The Grand-Unifying Ideas (GUIs) of the Vedic Religion

What are Grand-Unifying Ideas?

Every system of thought, whether religious or secular, contains ideas, which may be called the Grand-Unifying Ideas (GUIs) of that system. The GUIs are the central truths of the thought-system; all other truths within the system are either derived from the GUIs or are connected to them in some demonstrable way. For example, the GUI of the Abrahamic religions -- Judaism, Christianity, and Islam -- is the idea of an exclusive-monotheistic God. God, according to the Abrahamic religions, is the creator of the universe and His grace leads to salvation. Thus the GUI, God, is closely connected with the cosmological model and the idea of salvation, both of which are important aspects of religious thought. These ideas, formed long ago in the Old Testament, were somewhat modified in the New Testament and the Holy Koran. Though the idea of an exclusive-monotheistic God is a powerful feature of the Abrahamic religions, the constraints inherent in the idea have led to religious intolerance and much violence throughout the course of history.

The Grand-Unifying ideas of the Vedic Religion

The Vedic religion, or Hinduism, has given the world not one but two magnificent GUIs, the first being the idea of *Ishwara* or the Lord, and the second being *Advaita*, or non-dualism. The idea of *Ishwara* is fully developed in the Vedic mantras and is explored further in the *Upanishads*. The origin of *Advaita* is also found in the Vedic mantras, e.g., in the *Nasadiya Suktam* in *Rigveda*. However, the full unfolding of the *Advaitic* theme occurs only in the *Upanishads*. The ideas of *Ishwara* and *Advaita* are not mutually exclusive; rather, the idea of *Ishwara* naturally leads to the idea of *Advaita*. These two ideas are at the core of the Hindu religious world-view and are the very basis of Indian civilization. The Vedic religion has also developed other important unifying ideas, such as those of *Dvaita Vedanta*, *Visistadvaita* and the dualistic *Sankhya*. However, even a brief examination of these will not be possible in this short paper.

The inclusiveness inherent in the ideas of *Ishwara* and *Advaita* confers to the Vedic religion the ability to bring peace and harmony to all the religions of the world. In addition, *Advaita* possesses the potential to reconcile the seemingly incompatible world-view of modern science with that of religion. A satisfactory exploration of these important themes will require the writing of a long paper or even a book. However, we will chiefly concern ourselves here with a brief examination of the idea of *Ishwara* in relation to that of an exclusive-monotheistic God. In addition, we will take a brief look at two approaches to the subject of *Advaita*, a theistic approach and a philosophical approach.

Ishwara and God

“Truth is One, the wise call It by various names as Agni, Yama, Matarishvan.” These famous lines from *Rigveda* concisely state the ideal of *Ishwara*, or the Lord, which holds that all the deities are but various manifestations of *Ishwara*. This conviction, that the same Lord is being worshipped all over the world in different forms (or without any form) and by different names, is quintessentially a Hindu idea. Conversely, any deity of one’s preference (*Ishtam*) may be worshipped as *Ishwara*. In contrast, the First Commandment of the Old Testament states “You shall have no other gods before Me” and is interpreted by the followers of the Abrahamic religions to mean, “You shall worship no god other than Me.” The exclusivity intrinsic to the Commandment results in the branding of the deities of all other sects and religions as “False gods.” The Hindus accept all religions of the world as valid paths to salvation in spite of the differences that may exist in their basic tenets. More than a hundred years ago, Sri Ramakrishna Paramahansa expressed this liberality of view: “The one *Sat-Chit-Ananda* (Existence-Consciousness-Bliss) is invoked by some as God, by some as Allah, by some as Hari and by others as Brahman.”

The concept that “The Lord is infinite, His names are infinite and His forms are infinite” (*Hari ananta, Hari nama ananta, Hari roopa ananta*) validates all names and all forms that humans may ascribe to *Ishwara*. In contrast, the Second Commandment states, “You shall not make any graven images.” This effectively confines the followers of the Abrahamic religions to worshipping God without giving him form even though the Biblical God is anthropomorphic. The Biblical God is thought to have the form of a human being, or, more accurately, He has created man in His own image.

Many young Hindus in the USA tend to look at their own religion through the lens of Christian ideas. Thus, they harbor thoughts that the Vedic religion is polytheistic and that the Hindus worship idols. Many of these youngsters are frankly ashamed of their own religion. It is important for them to understand that the Hindus worship *Ishwara* in countless forms, and that the Hindus respect the choices made by every other religion of the world in matters of worship and faith.

Historically, the implications of the First and the Second Commandments have roused the followers of Christianity and Islam to a missionary zeal and an iconoclastic fervor not seen among any other of the world religions. This is however not true of the Jews, to

whom the Ten Commandments were given by God in the first place as recorded in the Old Testament. How is one to understand this paradox? The Jews have never tried to convert others to their faith, nor have they persecuted others because of religion; on the contrary, the Jews have themselves been persecuted throughout their long history. The interpretation that I attempt here is influenced by the Hindu way of looking at religious differences. We Hindus accept that the Biblical God is also *Ishwara* and is therefore infinite. The human mind, however, is finite. Revelations from God, such as the receiving of the Ten Commandments, are readings of the infinite by the finite mind, and are thus limited by the circumstances of the revelations. The first and the second Commandments were given to the Jews to save them from being swallowed up by their much stronger neighbors; the Egyptians, the Babylonians, the Greeks, etc. Moses received the Ten Commandments at a very crucial period in Jewish history, during which the Jews were fleeing slavery in Egypt. To survive as a people they had to set themselves starkly apart from their often-hostile neighbors. The First and Second Commandments achieved this purpose by creating a defensive fence around the Jews. The First and Second Commandments became arguments for conversion only after the advent of Christianity, at which point the deity of the Old Testament came to be projected as the universal God who alone should be worshipped by all the people of the world through His only begotten son, Lord Jesus.

Two Approaches to Advaita or Non-dualism: Theistic and Non-Theistic

Purusha Suktam, which is found in all the four Vedas, states, “The *Purusha* (or *Ishwara*) indeed is all this (i.e., the universe), what was and what will be. The Lord of immortality transcends all material forms.” This understanding of *Ishwara* as the unity underlying the apparent diversity of the world constitutes the theistic approach to *Advaita*. *Ishwara* is both immanent and transcendent. He is both the material cause of the world and its efficient cause. The multiplicity of names and forms in the universe is nothing but an appearance. In truth, the universe, the worshipper, and the worshipped are nothing but *Ishwara*. It is not just that *Ishwara* is one, rather, there is only *Ishwara*. People who are ignorant of this truth suffer the travails of *samsara*, the phenomenal world. The wise ones who realize this truth by knowing *Ishwara* attain immortality by overcoming *samsara*. This vision of unity in the Vedas can be contrasted with the teachings of the Abrahamic scriptures, which are almost entirely dualistic. They consider it a blasphemy to proclaim, “I am He.” However, we hear the echoes of *Advaita* in some sayings of Lord Jesus, for example, “I and my Father are one.” Christians admit the truth of this statement only in the case of the Christ, but not in others. In Islam, many Sufi saints have made ecstatic declarations of unity with the divine. However, in the Abrahamic traditions, the policies of the clergy and of the dominant churches are not in favor of exploring *Advaita*. It is quite possible that these *Advaitic* trends in the Abrahamic religions were stimulated by their contact with Indian thought.

The second approach, an intellectually rigorous and philosophical approach to *Advaita*, is found in the Upanishads. This approach, which goes beyond the idea of a personal deity, may be called the non-theistic approach. The Upanishads undertake an analysis of the relationship between the observer and the observed, and of the valid means of knowledge. The complete identity of the observer with the observed is declared in the *Maha Vakyas*, e.g. “*Tat Tvam Asi*,” or “That You Are.” The non-dual truth is shown to be beyond all categories of space, time, and causation, yet it is the source, the sustenance, and the final refuge of the phenomenal world. These ideas have entered modern physics only in the last hundred years or so. The implications of non-dualism have been explored exhaustively by both Buddhist (e.g. Nagarjuna) and Hindu (e.g., Gauda Pada and Shankara) philosophers. Their contributions have built the rigorous intellectual structures of the religions of India, which are capable of assimilating even the latest discoveries of modern science.

Conclusion: The Importance of Articulating Our Religious World-view

The Vedic religion has a message of peace and hope to offer the world. The essence of the message is contained in the two grand-unifying ideas of *Ishwara* and of *Advaita*. It is crucial that we fully understand the relevance of this message and articulate it to our non-Hindu friends. Perhaps more importantly, we must explain these ideas to our children growing up in the USA. The young Hindus in the USA face pressures and entertain doubts about their religion that we did not experience while growing up in India. It is essential that we teach them the intellectual structure of the Vedic religion so that they can be confident about the validity of their religion and be able to hold their own in discussions with their non-Hindu friends. Peace, understanding, and harmony among the various religions and between science and religion can be achieved only through the proper understanding and articulation of the grand-unifying ideas of the Vedic religion.

Suresh Shenoy grew up near Mangalore in Karnataka. He got his B. Tech from IIT, Madras in Mechanical Engineering and attended graduate school at the University of Florida, where he earned a Ph. D. in Nuclear Engineering. He is currently employed at Alstom Power Company in Connecticut as a senior consulting engineer. Suresh lives in Wallingford, CT with his wife and two children. His interests include the study of world religions, religious and secular philosophies and the emerging world-view of modern science.

UPDATE ON MITHUN – June 2002

Mithun does not need to make his quarterly trips to OHSU (Oregon Health Sciences University) at Portland because the first experimental protocol in which he was enrolled in was discontinued on February 1. Due to dramatic results in subsequent trials and the rapid approval of this miracle drug, Gleevec, OHSU decided that local oncologists could care for their patients. Mithun is continuing to take his 'miracle' pills under the supervision of Dr. Raj Warriar at Children's Hospital in New Orleans. We owe our deepest gratitude to Dr. Druker, who was responsible for the development and testing of this breakthrough drug, and for accepting Mithun for treatment into his new protocol in December 1999. Mithun is the second pediatric patient in the trial of this drug. We pray and wish Dr. Druker continued success. We feel he is a strong contender for the Nobel Prize for this breakthrough discovery of molecularly targeted oral medicine with hardly any side effects.

Mithun is finishing his 10th grade and studying for his SAT exam this summer. We are looking forward to the Konkani Sarmelan 2002 in Houston this July 4th weekend. We will be helping in the bone marrow drive held there. If you are not already registered, we hope and urge all of you to consider registering at this time. We will be happy to talk to you about the importance of being a donor.

We are grateful to the Konkani community and Khabbar for all their support. We will be happy to share our experiences with anyone who is going through a similar crisis and who may need advice and support. Thanks also to those of you who donated last month to the Leukemia and Lymphoma Society (LLS) in response to Maya Shenoy's (Mithun's aunt) appeal. The LLS heavily funded Dr. Druker's studies, which resulted in this miracle drug, Gleevec.

Even though Mithun may not need a bone marrow transplant any more, we continue to work towards adding more bone marrow donors to the National Registry for the sake of many other less fortunate cancer patients whose life depends on bone marrow from a matched donor. Through our crisis, we have realized how important the Gift of Life is. Bone marrow, when donated to save a life, replenishes within 3-4 weeks, just like blood donation with absolutely no loss to the donor. Without a suitable HLA matched donor, the chance of survival is slim for many cancer patients. Those of you, who have not yet become a part of the registry, please give it serious consideration. You may be able to save a life.
